AN ORDINANCE AMENDING CHAPTER XIV FIRE PREVENTION OF "REVISED GENERAL ORDINANCES OF THE BOROUGH OF DEAL, 1982"

Be it ordained by the Board of Commissioners of the Borough of Deal, in the County of Monmouth, as follows:

Section 1

Section 14-3.13 is hereby added to read as follows:

14-3.13 Fire Watch Conditions, Standby Personnel, and Special Events Personnel

a) Fire Watch Conditions – A fire watch is initiated by the fire department as a temporary measure to ensure continuous and systematic surveillance of a building or property, or portion thereof,

by one or more qualified individuals for the purpose of identifying and controlling fire hazards, detecting early signs of unwanted fire, raising an alarm of fire. Where conditions exist that are deemed an imminent hazard, or hazardous to life and property by the fire official, fire department standby crews shall be deemed as necessary by the fire official for the following, but not limited to, conditions (exemption – residential use):

- 1) Any building occupied with impaired fire protection systems
- 2) Buildings, rooms, or public venues exceeding the occupant load
- 3) Situations were fire load is greater than normal day-to-day operations
- 4) Events and displays, because of nature of performance, exhibition, display, contest, or activity. Open burn and recreational fires more than 3 ft x 3 ft.
- 5) As deemed by the fire official
- b) Standby Personnel and Special Events Personnel A firefighter standby fee shall be paid by the owner of the building or company or individual hosting a public venue. Fire Department standby fees shall be as follows:
 - 1) Fire Apparatus: \$135.00 per hour
 - 2) Firefighter and/or First Aider (EMT): \$45.00 per hour
 - 3) Fire Officer: \$55.00 per hour
 - 4) Fire Official or Fire Inspector: \$65.00 per hour
