Ms. Coffey also stated that a homeowner north of Roseld Avenue has constructed an eruy on the beach and that they have taken over public land and looked unsightly. Ms. Coffey was advised that no land was given to the homeowner. Ms. Coffey asked about changing the official newspaper from the Coaster. Ms. Coffey was advised that the Borough must utilize a paper that is circulated within the Borough. Ms. Coffey stated she would like to look into another possible official newspaper for notices. Ms. Coffey inquired about the cost for picking up leaves by the town. Mayor Ades stated that he went and drove around town for 2 hours after last meeting and saw no leaves in the streets. Ms. Coffey stated she never said there were leaves in the street and was disagreed by Mayor Ades. Mayor Ades stated that the town will only pick up leaves that had fallen from Borough trees.
