Isadora Chamlin, 5 Poplar Avenue, stated to the Commissioners that construction has been starting at 7:30 am in violation of Borough Ordinance which is 8:00 am. The police department will look into the construction sites and enforce the ordinance. Mrs. Chamlin asked if residents during the winter months can leave lights on outside their residents. Mayor Cohen stated that the Borough may send a letter next summer to residents asking to leave lights on outside the house during the winter months.

Jim Markey, Jersey Central Power & Light, addressed the Commissioners about a public service announcement. Mr. Markey advised that he has been seeing very serious storms and asked residents to be cautious. Mr. Markey also advised they will be conducting a lineman class at Brookdale to increase staff. Isadora Chamlin, 5 Poplar Avenue, stated to the Commissioners that she constantly hears music at Phillips Avenue and the Deal Casino. Mayor Cohen advised Mrs. Chamlin to contact the police with noise complaints. Mrs. Chamlin also asked if the pier at Phillips Avenue would be rebuilt, Mayor Cohen stated Senator Beck is looking into funding options for the Borough.

Mayor Cohen asked for any additional comments from the public, which there was none and closed the floor to public comments.

It was announced that the next meeting of the Board of Commissioners will be on Friday, October 14, 2016 at 9:00 A.M.
