ORDINANCE No. 1196

AN ORDINANCE AMENDING CHAPTER VI OF "REVISED GENERAL ORDINANCES OF THE BOROUGH OF DEAL, 1982" Beach Regulations

THE BOARD OF COMMISSIONERS OF THE BOROUGH OF DEAL HEREBY ORDAIN:

Section 1

Chapter 6-1 W. Stanley Conover Pavilion

6-1.4 Rates; Charges; Qualifications for Use.

The Pavilion will be open Monday-Thursday from 10:00am until 7:00 pm. On Fridays, Saturdays, Sundays and Holidays the Pavilion will be open from 9:00am-7:00 pm.

The beach will be open and lifeguards on duty Monday-Thursday from 10:00 am until 6:00 pm. On Fridays, Saturday, Sundays and Holidays the beach will be open from 9:00 am until 6:00 pm.

The Borough reserves the right to close beaches or other areas during inclement weather or other emergent situations

6-1.8 GENERAL CODE OF CONDUCT

In addition to the rules, each member and their guests are expected to be respectful to all staff and all fellow members at all times. Therefore, any loud and/or offensive language and obscene or inappropriate behavior is forbidden at all times. Only the beach management is responsible for instructing as well as disciplining staff. Members and guest shall NOT criticize or denigrate staff in ANY WAY. Members are encouraged to report immediately to any beach employee any conditions or actions deemed hazardous to health and safety, complaints by a member regarding staff behavior and performance must only be made to management. To ensure that complaints are received and addressed appropriately, all complaints should be reduced to writing, signed by a member and left with the management.

Chapter 6-2 Deal Casino Beach Club

6-2.2, Club Rules and Regulations at the Deal Casino are amended to read as follows:

3. APPLICATION AND PAYMENT DEADLINE

A \$500 deposit to hold your bath house due on <u>December 2</u>. If deposits are NOT received by this date your bath house will be given away to someone on the waitlist. Payment in full is due by <u>April 15</u>.

If payment in full is not received by April 15 a \$250 late fee will be added to your total. If payment in full is not received by April 30 a \$350 late fee will be added to your total and the bath house must be paid for no later than April 1. If your payment is still not received by April 1, the bath house will be given away to the next person on the wait list and all deposits will be forfeited.

THESE DATES WILL BE STRICTLY FOLLOWED AND THERE WILL BE NO EXCEPTIONS MADE.

4. HOURS

The beach club will be open Monday-Thursday from 10:00am until 7:00 pm. On Fridays, Saturdays, Sundays and Holidays the beach club will be open from 9:00am-7:00 pm.

The beach will be open and lifeguards on duty Monday-Thursday from 10:00 am until 6:00 pm. On Fridays, Saturday, Sundays and Holidays the beach will be open from 9:00 am until 6:00 pm.

The Borough reserves the right to close beaches or other areas during inclement weather or other emergent situations.

6. GUESTS

All guest passes must be purchased by a member of the club and can be done so ahead of time online (www.dealborough.com) or at the casino office. Each bathhouse is limited to 40 peak passes for the season. Off-peak passes are unlimited.

Peak times are Fridays, Saturdays, Sundays and Holidays between the hours of 9am-4pm. Off-peak times will be Monday – Thursday between the hours of 10am-8pm and Fridays, Saturdays, Sundays and Holidays after 4pm.

Guest passes purchased will not expire and may be used at any time. Upon cancellation of membership, the associated passes will no longer be valid. Absolutely no refunds or rainchecks will be issued for guest passes.

Sale and purchase of guest passes other than from the Borough of Deal is prohibited.

Any member found bringing a guest into the Beach Club without paying the guest fee will be subject to revocation of membership.

10. FURNITURE

Beach Club furniture may not be moved from pool deck, common areas, eating areas, or pool side cabanas. Furniture which is included with cabanas or beach houses is reserved for that specific unit only. Misplaced furniture will be removed. Reserving or rearranging pool deck furniture is prohibited. No Glass Tables will be allowed on beach club property. Refrigerator over 11 cubic feet will be assessed a \$200 surcharge. Refrigerators shall be placed in a deluxe cabana and plugged directly into the receptacle, use of extension cords is prohibited.

No outside furniture, rugs or other furnishings may be permitted onto the Deal Casino premises unless expressly approved by Deal Casino Management in writing. Any outside furniture that is brought onto the premises without written permission may be removed and discarded without notice.

11. GLASSWARE AND FOOD

There is no eating anywhere on pool deck. Additionally, no glass of any kind is allowed on pool deck. Absolutely No Exceptions. Food is permitted at designated eating areas and the Beach houses and Cabanas. The use of cooking appliances is prohibited at the beach club. Appliances other than refrigerator are also prohibited. The use of extension cords is prohibited, one 15 amp power strip with a 2 foot cord is permissible.

12. USE OF BEACHES

Bathers are forbidden to bathe outside the designated areas and unprotected areas, or at such times, when in the opinion of the Management or Lifeguards, ocean bathing is unsafe. Operation and use of Jet Skis are prohibited on Deal beaches expect for use by emergency personnel and lifeguards. The use of surf boards on the beaches of the Conover Pavilion and the Deal Casino are prohibited during the hours the clubs are open. Any person using diving apparatus or other equipment whether or not belonging to the Deal Casino, does so at his or her own risk.

15. SKATE BOARDS

The use of roller blades, roller skates, skate boards or in-line skates are prohibited on Deal Casino property. Wheeled vehicles shall not be permitted inside the Casino, which is include but not limited to scooters and bicycles not owned by the Borough of Deal.

16. POOL CONDUCT

Ball playing, floating objects, swim boards, tubes, etc. will only be allowed at the discretion of the lifeguards when it is deemed safe in either the main or baby pools. Children using swimmies are permitted if accompanied in the pool by an adult. **Children in**

diapers are not allowed in either pool per the New Jersey Sanitary Code.

17. BABY STROLLERS

Baby strollers are permitted around the pool deck area. For safety purposes, play pens are prohibited at pool side deck area.

25. SMOKING

Smoking is prohibited inside the Deal Casino and on the Beach.

6-4 Bathing in Unprotected Waters

6-4.2 Definitions

- D. Bathing shall mean to enter the water to the extent that the water, or action of the waves, causes the person's waistline to be below the surface of the water, for any length of time.
- E. Swimming shall mean the act of propelling oneself through the water by natural means, such as the movement of limbs or to float on or at the surface of the water.
- F. Bathing and Swimming in unprotected water shall be permitted only when the person is in possession of, and physically tethered to a: surfboard, body or boogie board capable of maintaining the weight of the person, paddleboard, or any Type I, II or III U.S. Coast Guard approved personal flotation device.

SECTION 2

Charges to be reviewed annually and dates adjusted to accommodate the operations calendar. The user charges set by this ordinance shall be

reviewed annually and revised periodically by resolution of the Board of Commissioners to reflect actual costs associated with the operation of the Deal Casino and the Conover pavilion.

SECTION 3

This Ordinance shall take effect upon passage and publication according to law

AN ORDINANCE AUTHORIZING THE DRAINAGE EASMENT INTEREST IN A PORTION OF THE REAL PROPERTY LOCATED AT 82 BRIGHTON AVENUE, KNOWN AS BLOCK 30, LOT 6

WHEREAS, in accordance with N.J.S.A. 40A:12-5(a)(1) "any municipality, by ordinance, may provide for the acquisition of any real property, capital improvement, or personal property: (1) by purchase, gift, devise, lease, exchange, or condemnation;" and

WHEREAS, there is a need to improve the stormwater facilities servicing the Brighton Avenue Brook; and

WHEREAS, through consultation with the Borough's Engineer, Leon S. Avakian Inc., the Borough has determined that an improved stormwater management system would be facilitated by replacing the stormwater drainage system from the rear of 82 Brighton, Block 30 Lot 6, out to Brighton Avenue Right of Way and then east to Ocean Avenue; and

WHEREAS, Leon S. Avakian Engineering, Inc., has designed a proposed upgrade and revisions to the drainage system to improve capacity, which improvements will require the Borough to acquire a drainage and construction easement over a portion of property located at 82 Brighton Avenue, also known as Block 30, Lot 6, as identified in the attached parcel description by metes and bounds, in the Borough of Deal; and

WHEREAS, based upon the goal of mitigating the impact of stormwater in the area and mitigating the risk of flooding due to the presence of stormwater in the area and in consultation with the Borough's Engineer, the Borough has identified the property located at 82 Brighton Avenue as a necessary location on which to locate certain improvements related to the proposed flood mitigation project.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Deal:

Mrs. Chamlin stated that Maria is doing a great job keeping the Casino clean. Mrs. Chamlin spoke about vehicles turning on Norwood Avenue from the wrong lane. Mrs. Chamlin was advised that NJDOT was asked to put lane markings between the islands but would not approve them.

Mary Anne Cronheim, 88 Monmouth Drive, stated to the Board of Commissioners that she agrees about Maria at the Casino and works very hard. Mrs. Cronheim stated there is a lot of encroachment on the center of the aisles from furniture. Mayor Cohen stated that he was going to change the rules for that. Mrs. Cronheim stated that there were traffic issues where people were walking in the center of the roadway and bicyclists not following the laws. Mrs. Cronheim asked the reason for the architect at the Deal Casino Mayor Cohen stated that they are looking to design deluxe beach houses on the southside of the property in front of Kaudory's lot for residents only. Mayor Cohen also stated that he was seeking a towel service again for the Casino. Mrs. Cronheim asked who was the committee to work on the design for the beach houses, Mayor Cohen stated the Commissioners would be the committee.

Irwin Levine, 28 Richmond Avenue, asked if there would be landscape features, Mayor Cohen stated that there will not be any landscape features but would provide parking for each beach house.

Mary Anne Cronheim, asked if the new beach houses would be offered to current members first, Mayor Cohen stated they would be offered to Deal Residents only. Mrs. Cronheim stated that they cannot take away from parking for current members. Mayor Cohen stated that the parking spots will be by the beach houses in the overflow parking lot. Mrs. Cronheim stated she would like preferred parking. Commissioner Ades stated we will provide parking for members that pay extra for it. Mrs. Cronheim asked about the relocation list. Mrs. Cronheim was advised when and how the list is created and how the members are relocated.

Mayor Cohen asked for any additional comments from the public, which there was none and closed the floor to public comments.

It was announced that the next meeting of the Board of Commissioners, which will be on Friday, October 11, 2019 at 9:00 A.M.

There being no further business or comments, it was moved by Mayor Cohen and seconded by Commissioner Simhon that the meeting be adjourned at 9:39 A.M.
