ORDINANCE 1220

AN ORDINANCE AMENDING CHAPTER XI OF "REVISED GENERAL ORDINANCES OF THE BOROUGH OF DEAL, 1982", Streets and Sidewalks

THE BOARD OF COMMISSIONERS OF THE BOROUGH OF DEAL HEREBY ORDAIN:

Section 1. That Chapter XI, Streets and Sidewalks, of the "Revised General Ordinance of the Borough of Deal, 1982 be and it hereby is amended in the following particulars:

Section 2. Subsection 11-4 Trees is added as follows:

11-4.1 Purpose.

It is the intent of this chapter to promote the general welfare of the people of the Borough by providing for the protection, regulation and planting and cutting of trees in such a way as to protect and preserve the environment by conserving to the maximum extent possible the tree life in the Borough.

11-4.2 Trees on Public Right of Way.

Where a person desires to control the growth of trees on a public highway, street or road or right-of-way by removing them or pruning the trees, then the person shall apply for approval to the Borough Administrator and shall outline the work to be performed. If the applicant fails to comply with the order of the Borough Administrator, the applicant shall be subject to the penalties as hereinafter provided.

11-4.3 Violations; Penalties.

Each tree cut, damaged or destroyed in violation of this chapter shall be deemed to be a separate and distinct violation. Any person convicted of violating any of the provisions of this chapter shall be liable to the penalty stated in Chapter 5, Section 9.1

SECTION 3. If any part of this Ordinance shall be deemed invalid such part shall be deemed severable and the invalidity thereof shall not affect the remaining part of this Ordinance.

SECTION 4. Any Ordinance or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed and superseded.

SECTION 5. This Ordinance shall take effect upon final passage and publication in accordance with Law.

Ordinance 1218 to amend Chapter XXX Development Regulation was introduced on April 1, 2020 and the public hearing is scheduled for today, June 3, 2020.
