Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

Mrs. Cronheim asked if the railroad tracks were open on Roseld Avenue, she was advised the construction has completed and the roadway is open. Mrs. Cronheim stated that she disagreed with the extension of the construction moratorium. Mayor Cohen stated that there was nothing that could be done at this time.
