15-21.1 Fees for Certain Services Established.

D. Firearm Applicant Fee:

- 1. Firearms, Identification Card: \$50.00
- 2. Firearms, Permits to Purchase: \$25.00
- 4. Firearms, Permit to Carry: \$150.00 and \$50.00 shall be remitted to the Superintendent of State Police to be deposited into the "Victims of Crime Compensation Office Account".

Section 3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

Section 4. All ordinances or parts of ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
