Barbara Coffey, 85 Norwood Avenue, stated she is concerned about adding parking meters to Conover, and asked if they will be throughout the town or just Conover.

Mayor Cohen advised her the metered parking system will just be at Conover. As well, he explained this is a parking system through a phone app with only one or two machines at the location for those who do not utilize the technology.

Barbara Coffey asked if the town will be adding a traffic light on Ocean Avenue due to increased traffic.

Barbara Coffey was advised no, but police will be there to monitor the traffic and pedestrian crossings.

Police Chief Ronen Neuman advised there will be portable signs in place during the summer due to high traffic as usual procedure.

Barbara Coffey asked if the residents of Marine Terrace were alerted regarding the new parking ordinance.

Barbara Coffey was advised the pending ordinance to be updated will only be on weekends and holidays, and the residents on Marine Terrace already experience high overflow during the summer.

Mary Anne Cronheim, 88 Monmouth Drive, asked for clarification if this area will be paved and if meters will be there.

Mayor Cohen responded there will be heavy duty grass at Conover parking as the DEP does not allow it to be paved. As well, he stated only one or two meters will be there, as well as an app will be provided to pay for parking.

Mary Ann Cronheim asked if the enforcement will only be through our police.

Mayor Cohen responded yes.

Mary Anne Cronheim stated she is concerned about the loss of revenue because people will go to other beaches with more amenities, and asked what the price will be for the metered parking. Mayor Cohen responded the prices will be \$2/hour or \$10/day.

No other comments were made and the public hearing was closed.
